"10A. Obligation to furnish information. - (1) Every Multi-System Operator and cable operator shall be bound to give such information as may be sought for by the Central Government or the State Government or any agency authorized by the Central Government or authorized officer, as the case may be, within such period and in such form as may be specified by such Government or agency or officer.

(2) The authorized signatory of the Multi-System Operator or cable operator providing the information sought for under sub-rule (1) shall also be required to affirm as to the correctness and truthfulness of the information so provided."

The obligation to furnish information under the amended rule 10 A has been incorporated as one of the terms and conditions of registration of cable operators under rule 5A and MSOs under rule 11D of the Cable Television Network Rules, 1994. The power to punish violations of the provisions of the newly amended Rules lies with Central Government and no delegation in this regard has been made.

(c) and (d) The Ministry is presently implementing the Digital Addressable System (DAS) in a phased time bound manner all over the country with complete switch off of analogue cable TV services by December, 2014. Digitalization with addressability in Cable services has, therefore, superseded the Conditional Access System (CAS). The Ministry is closely monitoring the preparedness of various activities for the implementation of DAS. Towards this end, a Task Force comprising representatives of all stakeholders has been set up to review the progress made towards the implementation of DAS. The Ministry has also launched an information and public awareness campaign. A Toll Free Telephone Number has been made operational to address and clarify various queries of public at large. A facebook account and a dedicated website have been set up to provide an interactive platform. Weekly reviews are taken to monitor the progress made towards installation of set top boxes.

Funds under the Welfare Institutions Scheme

*307. SHRI Y.S. CHOWDARY: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the details of funds released under the Welfare Institutions Scheme for supply of foodgrains during the last three years, State-wise;
 - (b) the details of funds spent/unspent during that period, State-wise;
 - (c) the details of the results achieved so far; and
 - (d) whether Government is satisfied with the results achieved so far?

THE MINISTER OF STATE OF THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (PROF. K.V. THOMAS): (a) to (d) With a view to meet the requirement of welfare institutions such as beggar homes, nariniketan etc. not covered under Targeted Public Distribution System (TPDS) or under any other welfare schemes, an additional allocation of foodgrains (rice and wheat) not exceeding 5% of the BPL allocation of each State/Union Territory Administration (UT) is made to States/UTs at BPL prices by the Central Government. Only foodgrains are allocated and there is no provision for release of funds. The allocation and off-take of foodgrains in respect of these Welfare Institutions for the last three years i.e. 2009-10 to 2011-12 is given in Statement (See below).

Targeted Public Distribution System (TPDS) including allocations to Welfare Institutions is operated under the joint responsibility of the Central Government and State Governments/UT Administrations. The Central Government is responsible for procurement, storage and its further allocation to the States/UTs. State Governments/UT Administrations are responsible for lifting the allocated foodgrains and its distribution within the States/UTs and in ensuring that the allocated foodgrains reach the targeted beneficiaries, particularly, the vulnerable sections of the population. It is observed from the off-take of food grains by the beneficiary States/UTs for the last three years as stated above that the results are satisfactory.
